

KONTEKST:

Potrebno utvrditi politički motivisano nasilje za vreme i nakon izbora 2011.godine u DR Kongu, u cilju analize i donošenja odluke u konkretnom slučaju, a povodom zahteva za azil lica poreklom iz DR Konga, prema izjavi iznetoj na zahtevu za azil i usmenoj raspravi;

PITANJE: Politički motivisano nasilje za vreme i nakon izbora 2011.godinei u DR Kongu

ODGOVOR:

Strah od nasilja i ugrozavanje slobode izražavanja zabrinjavao je inostrane zvanicnike pre i nakon održanih izbora.^{1 2}

Prvi slobodni viseštранаčki izbori u Demokratskoj Republici Kongo odrzani su 28. novembra 2011.godine.^{3 4 5} Na izborima je na petogodišnji mandat ponovo izabran Joseph Kabila.^{6 7}

Opšti izbori koji su održani u novembru 2011.godine propraćeni su brojnim nepravilnostima i kršenjima ljudskih prava, uključujući protivpravna ubistva i proizvoljna hapšenja od strane snaga bezbednosti.^{8 9 10 11} Nasilje od strane policije i drugih bezbednosnih snaga za vreme izbornog procesa uključivalo je ograničavanje političkih aktivnosti, prekoračenje upotrebe sile protiv demonstranata i proizvoljna hapšenja pre svega pripadnika opozicionih stranaka, njihovih pristalica i novinara.¹²

Ozbiljni incident dogodio se nedelju dana pre izbora, kada je 18 ljudi izgubilo život od strane predsedničke straže koja se oružjem sukobila sa demonstratorima.^{13 14}

Policija Konga se u nekoliko navrata tokom izbornog perioda sukobljavala sa pristalicama opozicione strane, članovima medija i borcima za ljudska prava,^{15 16 17} što je rezultiralo i ljudskim žrtvama.^{18 19}

Period posle izbora obeležila su nezakonita ubistva i hapšenja mnogih protestanata.²⁰

Ujedinjene nacije su u postizbornom periodu, od 26.novembra do 26.decembra 2011.godine zabeležile 33 ubistava od strane snaga bezbednosti,^{21 22} najmanje 83 ranjenih,²³ 16 nestalih i preko 260 pritvorenih civila, na području glavnog grada Kinšase.^{24 25} Većina pritvorenih civila je proizvoljno i nezakonito uhapšeno,²⁶ i neki od njih su prijavili slučajevе toture dok su boravili u pritvoru.²⁷ Prema izjavama svedoka posle izbijanja nemira u kojima su poginuli protestanti, uniformisani ljudi su bacali tela poginulih u reku Kongo,²⁸ dok su neka sahranjena u masovne grobnice.²⁹

Većina uhapšenih su pripadnici opozicione partije Unija za demokratiju i narodni napredak (Union pour la Democratie et le progres Social-UDPS), ili potiču iz iste provincije kao i opozicioni lider Etienne Tshisekedi.³⁰³¹

Strah od nasilja i ugrozavanje slobode izražavanja zabrinjavao je inostrane zvanicnike pre i nakon održanih izbora.³²³³

Opštu klimu tenzije nakon izbora je oslikao incident pri ‘Maršu hrišćana’ organizovanog od strane Katoličke crkve u znak protesta protiv navodne prevare održanim izborima.³⁴³⁵ Policija Kinšase je uz upotrebu oklopnih vozila i vodenih topova nastojala da spreči marš i okupljanje u crkvama. Pritom je nekolicini sveštenika i protestanata određen pritvor.³⁶³⁷

KOMENTAR/ZAKLJUČAK:

Iz prethodno navedenih tvrdnji proizilazi zaključak da je period pre i posle izbora 2011.godine u DR Kongu, bio obeležen nezakonitim ubistvima i hapšenjima opozicionih lidera i pistalica, od strane bezbednosnih snaga i policije. Takođe se može zaključiti da se samim tim vršila represija nad opozicijom i protestantima koji su izražavali svoje nezadovoljstvo zbog rezultata izbora.
